ORDER MO-070-2015

IN THE MATTER OF the *National Energy Board Act* (NEB Act) and the regulations made thereunder; and

IN THE MATTER OF an application made by Foothills Pipe Lines Ltd. (Foothills), pursuant to section 45.1 of the *National Energy Board Onshore Pipeline Regulations* (OPR), dated 25 September 2015, filed with the National Energy Board (Board) under File OF-Fac-Gas-F115-2015-02 01.

BEFORE the Board on 22 December 2015.

WHEREAS the Board received an application from Foothills, pursuant to section 45.1 of the OPR, dated 25 September 2015 to decommission a 9.1 km section of the 914 mm (NPS 36) Foothills Zone 8 Segment 2 (Leach Creek Segment) lateral loop (Project);

AND WHEREAS the information about the Project is set out in Schedule A, attached to and forming part of this Order;

AND WHEREAS the Board received subsequent filings from Foothills dated 2 November 2015.

AND WHEREAS Foothills submitted that the Leach Creek Segment has not been in operation for 12 months or more and Foothills has determined that it will not be returned to active service;

AND WHEREAS the Board has had regard to all considerations that are directly related to the Project and relevant, including environmental matters;

AND WHEREAS the Board has examined the application and subsequent filings and considers it to be in the public interest to grant the relief requested by Foothills;

IT IS ORDERED that, pursuant to section 45.1 of the OPR, the applied-for Project, as specified in Schedule A, is approved subject to the following conditions:

1. Foothills shall comply with all of the conditions contained in this Order unless the Board otherwise directs.

- 2. Foothills shall decommission and maintain the Leach Creek Segment in accordance with the specifications, standards, commitments made and other information referred to in its application or in its related submissions.
- 3. Foothills shall implement or cause to be implemented all of the policies, practices, programs, mitigation measures, recommendations, procedures and its commitments for the protection of the environment included in or referred to in its application or in its related submissions.
- 4. Within 30 days of the date that the decommissioning is completed, Foothills shall file with the Board a confirmation that the Project was completed in compliance with all applicable conditions in this Order. If compliance with any of these conditions cannot be confirmed, Foothills shall file with the Board details as to why compliance cannot be confirmed. The filing required by this condition shall include a statement confirming that the signatory to the filing is an officer of Foothills.
- 5. Unless the Board otherwise directs prior to 22 December 2016, this Order shall expire on 22 December 2016 unless the Project has commenced by that date.
