**Foothills Pipe Lines Ltd. (Foothills)
Compliance Filing—Collection Mechanism Filing (Compliance Filing)**

On November 25, 2014, Foothills submitted the Compliance Filing. In this filing, Foothills also applied to revise its Abandonment Cost Estimate (ACE) to \$197,869,000 using IHS Global Insight economic indices for costs related to abandonment activities. On 18 December 2014, the National Energy Board (Board) issued interim toll order TGI-006-2014.

The Board notes that shippers were provided an opportunity to file comments about the Compliance Filing within 14 calendar days of the filing date. The Board has not received any comments.

The Board approves Foothills' ACE, tariff amendments, abandonment surcharges, and annual contribution amount, as presented in the Compliance Filing, effective 1 January 2015 and issues the attached Order TG-004-2015 (Order).
